# Cookie Policy

This Cookie Policy is an integral part of the Legal Notice and Data Protection Policy of www.ledexport.com.

In any case, we inform you that the provider is responsible for the Cookies and for the processing of the data obtained through its own and third party Cookies, deciding on the purpose, content and use of the processing of the information collected.

### What is a Cookie?

Cookies are files containing small amounts of information that are downloaded to a user's device when they visit a website. Their main purpose is to recognize the user each time he or she accesses the Website, also allowing to improve the quality and offer a better use of the Website.

Cookies are essential for the operation of the Internet; they cannot damage the user's computer/device and, if activated in the configuration of your browser, they help to identify and resolve possible errors in the operation of the Website.

### Lender's Use of Cookies

We inform the user of the Website that we may use Cookies on your computer provided you have given your consent, except in cases where Cookies are necessary for navigation on our website. If the user gives his or her consent, we may use Cookies that will allow us to have more information about your preferences and to personalize our website according to your individual interests.

Specifically, Cookies are being used for the purposes set out below. If in the future the Provider uses others for the purpose of providing more and better services, the user will be informed of this.

In this regard, the Website may use its own technical Cookies, including the following:

The aforementioned Cookies are considered technical cookies, which are those that allow the user to navigate through a web page, platform or application and use the different options or services that exist in it, such as, for example, identifying language, control traffic and data communication, make subscriptions, use security elements while browsing, store content for the broadcast of videos or sound or share content through social networks.

Irrespective of the above, the website also uses Google Inc. performance cookies. These cookies collect anonymous information on how visitors use a website, for example, which pages visitors visit most often.

These Cookies belong to third parties and are considered analysis Cookies, which are those that allow the person in charge of the Cookies to track and analyze the behavior of the users of the website to which they are linked. The information collected by means of this type of cookie is used to measure the activity of the website, platform or application and to draw up navigation profiles of the users of the said website, platform or application, in order to introduce improvements based on the analysis of the usage data made by the users.

These cookies do not collect any identifying information about the visitor. All information collected by Cookies is collected and therefore anonymous. They are only used to improve the operation of a website. Depending on their duration, cookies can be:

Session cookies: these are a type of cookie designed to collect and store data while the user accesses a website. These cookies are not stored on the user's computer when the session expires or the user closes the browser.

Persistent: these are a type of cookie in which the data is still stored in the user's computer and can be accessed and processed when the user leaves the website and when he/she reconnects to it. These cookies can be deleted at any time by the user.

Depending on the entity that manages them:

Own cookies: are those sent to the user's terminal equipment from a computer or domain managed by the owner of the website and from which the service requested by the user is provided.

Third-party cookies: are those sent to the user's terminal equipment from a computer or domain that is not managed by the owner of the website from which the service requested by the user is provided, but by another entity that processes the data obtained through cookies. Likewise, in the event that the cookies are installed from a computer or domain managed by the owner of the website itself but the information collected through them is managed by a third party, they will also be considered as third party cookies.

### Revocation and Deletion of Cookies

Once the user has accepted the use of Cookies, he may also withdraw his consent to the Cookie Policy at any time, and may delete the Cookies stored on his computer, without prejudice to the validity of the processing carried out up to that point.
